## Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form. You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an

authorisation form allowing your vehicle to enter the exhibition grounds, along with the gate through which you should enter. The direct link to the online registration is: [www.gateway.messefrankfurt.com](http://www.gateway.messefrankfurt.com)  
**Please note:** In case of high volume of traffic waiting times are possible at the Check-In! All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense. [back](#)

## Car parking spaces

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t and for car trailers. Please use the Shop for Exhibitor Services ([www.serviceshop.messefrankfurt.com](http://www.serviceshop.messefrankfurt.com)) to make your reservations by no later than four weeks before the start of the event. It may not be possible to honour orders made after this time.

### Truck parking spaces

You may park your vehicle for set-up/dismantling at the Rebstock E1 truck park for a fee for general dismantling activities. Reservations are not required.

**Parking permits will not be sent by e-mail until the ordering deadline has passed.**

## Set-up

### Advanced set-up 30 + 31 January

Please note that it is not possible to [register](#) vehicles until confirmation for advance set-up has been received.

Advanced set-up must be ordered from the Shop for Exhibitor Services ([www.serviceshop.messefrankfurt.com](http://www.serviceshop.messefrankfurt.com)). **For stands under 300 sqm, the advanced set-up is available for a fee.**

Please note that cars and transporters up to 3.5t are only allowed on the parking decks of hall 4 (P4), hall 9 (P9) and hall 12 (P12) during set-up and dismantling period.

**For a deposit of € 100 in cash, you can also drive for 1 hour directly to the loading zones of the exhibition halls.**

### Set-up 1 – 6 February

[Registration](#) required

**Set-up ends 25 January by 3 p.m.**

**Please note that the aisles must be clear from 3 p.m. on 25 January. After that, set-up is only possible within the stands.**

Please note that cars and transporters up to 3.5t are only allowed on the parking decks of hall 4 (P4) during set-up and dismantling period.

**For a deposit of € 100 in cash, you can also drive for 1 hour directly to the loading zones of the exhibition halls.**

## Trade fair

### Deliveries during trade fair 7 – 10 February

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. **All other vehicles will only be allowed to enter with a valid parking permit.**

### Last day of the trade fair 11 February

- Entry will not be permitted after 2 p.m.
- From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the E1 assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass.

### Admission for special dismantling vehicles 11 February, 5 p.m. – 8 p.m.

for exhibitors, for the transport of smaller loads by cars and vans up to 3.5 t gross vehicle weight rating. Pre-ordering is not possible, but a max. of 400 of these special permits are issued. Therefore, you should take care of it early: 6 – 11.2, 10 a.m. to 2 p.m. at the Central Information Desk on Level 02 of the Torhaus.

- Presentation of a customer number
- Presentation of the exhibitor pass
- Signing a declaration that you will be charged an additional €200.00 when invoiced for your ancillary costs if you leave the exhibition grounds after 8 p.m.

**Please note that you will not be able to use the goods lifts.**

## Dismantling

### General admission for dismantling vehicles 11 February after 9 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 9 p.m.

Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.

**Attention: For the last day of the fair and the dismantling entrance registration is not possible.**

**Dismantling ends at 9 p.m. on 14 February.**
