Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form: <https://gateway.messefrankfurt.com>
You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. As soon as a loading zone becomes available, you will be given an authorisation form allowing your vehicle to enter the

exhibition grounds.

Please note: In case of high volume of traffic waiting times are possible at the Check-In!

All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense.

Parking spaces

Parking permits for cars up to 2.5 t gross vehicle weight and car trailers can be ordered for a fee from the Shop for Exhibitor Services (www.serviceshop.messefrankfurt.com) for the exhibition grounds or the Messe Parkhaus Rebstock (no trailers). The parking tickets will be made available to you digitally and must be printed out and carried in your car.

Orders placed after the order deadline (4 weeks before the event) may no longer be served.

Truck parking spaces for set-up and dismantling vehicles are available on the Rebstock, Block E1 from 1. - 9.11.. They are subject to a charge and must be paid on site.

Set-up

Advanced set-up 25 – 31 October 2024

Please note that it is not possible to **register** vehicles until confirmation for advance set-up has been received.

Advanced set-up must be ordered from the Shop for Exhibitor Services (www.serviceshop.messefrankfurt.com). **Advanced set-up is free of charge.**

Set-up 1 – 5 November 2024

Registration required.

All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense

For a deposit of €100 in cash, you can also park for 1 hour directly at the loading zones of the exhibition halls.

Set-up ends at 3 p.m. on 5 November 2024 due to carpet installation. You can still set up inside the stands.

Trade fair

Deliveries during trade fair 6 – 8 November 2024

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit.

Last day of the trade fair 9 November 2024

- Entry will not be permitted after 2 p.m.
- From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the E1 assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass.

Dismantling

General admission for dismantling vehicles 9 November 2024 after 7 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park E1. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 7 p.m.

Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.

Attention: It is not necessary to register for the last day of trade fair and the dismantling entrance.
